Dear Jamie:

On Wednesday, August 18, 2010, representatives from South Florida Racing Association, LLC (SFRA) and the Florida Quarter Horse Racing Association (FQHRA) convened at Hialeah Park to begin negotiating a binding agreement to encompass, at a minimum, the impending race meet at Hialeah Park scheduled to commence on Friday, November 26, 2010 and conclude on January 2, 2011, for a total of twenty-two (22) live race days. These contractual negotiations were finalized on Monday, August 30, 2010, yielding an agreement for a term of six (6) years.

During the aforementioned discussion, several salient points were put forth regarding the start date and duration of the SFRA scheduled race meet. In the spirit of cooperation and in the hope of maximizing revenues for all parties involved, including the State of Florida, plus further advancing all aspects of Florida's Quarter Horse industry, SFRA respectfully submits this request to amend the previously submitted application for an annual operating license to comply with what was agreed upon between SFRA and FQHRA in the ensuing contractual discussions.

Enclosed, herewith, are the revised DBPR PMW forms 3060 and 3080 enumerating the requested minor changes of conducting twenty-four (24) performances of Quarter Horse Racing commencing on December 3, 2010, and concluding on Sunday, January 23, 2011. At this time, the original DBPR PMW 3190 form previously submitted on December 30, 2009, remains unchanged.

In conclusion, South Florida Racing Association, LLC respectfully requests the issuance of an annual operating license for the amended racing dates applied for herein.
