COMPLAINT

Comes the Plaintiff, Adam Thomason, and hereby complains against the Defendant, Underdog Sports, LLC, as follows:

**INTRODUCTION**

1. Defendant operates a popular online gaming platform called Underdog Fantasy, accessible on the Internet at <https://underdogfantasy.com> and also on a mobile phone application.
2. At Underdog Fantasy, Defendant offer Georgians the opportunity to play so-called “Pick ’Em” games related to sports and other contests. Defendant projects that an athlete or other contest participant will have certain statistics in an event. An Underdog Fantasy user picks whether the athlete or other participant will meet the projection or not. If the user picks correctly, he wins real money, which he can withdraw or use in subsequent bets.
3. Defendant’s Pick ’Em games are illegal gambling under Georgia law. They are no different than giving money to a bookie to bet on a sports team to win a game.
4. Plaintiff brings this action to recover Georgia users’ losses at Underdog Fantasy, as permitted by O.C.G.A. § 13-8-3(b).

## **JURISDICTION AND VENUE**

5. The Court has subject matter jurisdiction over this action pursuant to Ga. Const. art. VI, § IV, ¶ I and O.C.G.A. § 15-6-8.

6. This Court has personal jurisdiction over Defendant pursuant to Georgia's long-arm statute, O.C.G.A. § 9-10-91(1), because Defendant purposefully transacted business in Georgia, Plaintiff's cause of action against Defendant arises from those acts, and the exercise of jurisdiction by this Court does offend traditional fairness and substantial justice.

7. Venue is proper pursuant to O.C.G.A. § 9-10-93 because Defendant transacted a substantial part of the business at issue in Fulton County. More specifically, a substantial number of people in Fulton County lost bets to Defendant at Underdog Fantasy, as described herein. Defendant was not residing, domiciled, organized, existing, or authorized to transact business in Georgia at any time relevant to this action.

## **PARTIES**

8. Plaintiff Adam Thomason is a natural person and a citizen of Georgia. Plaintiff has not registered at Underdog Fantasy or used Underdog Fantasy. Plaintiff opposes Defendant's gambling business on moral and social grounds. He brings this lawsuit pursuant to O.C.G.A. § 13-8-3(b) to recover gambling losses for the joint use of himself and the educational fund of the county.

9. Defendant Underdog Sports, LLC is a limited liability company organized under the laws of Delaware. Defendant's principal place of business is at 150 Waterbury Street, Brooklyn, New York 11206. Defendant maintains a registered agent at Vcorp Agent Services, Inc., 108 W. 13th Street, Suite 100, Wilmington, Delaware 19801. Defendant conducts business throughout Fulton County and Georgia.

### FACTUAL ALLEGATIONS

10. To use Underdog Fantasy, someone first has to register an account by providing a user name, email address, password, and date of birth to Defendant. Defendant requires additional personal details and a form of legal identification to verify the user's identity.

11. Once a user completes the verification process, he can deposit funds with Defendant. Defendant accepts deposits by several means, including credit cards, debit cards, instant bank transfers, and PayPal.

12. After registering and depositing funds, a user can start making picks at Underdog Fantasy.

13. Defendant makes projections in a variety of sports, including professional football, professional basketball, professional baseball, professional soccer, college sports, and even video game competitions called "esports."

14. Defendant's projections involve a wide range of player metrics. In football alone, the metrics include passing yards, receiving yards, rushing yards, passing touchdowns, receptions, field goals made, sacks, and combinations of the foregoing.

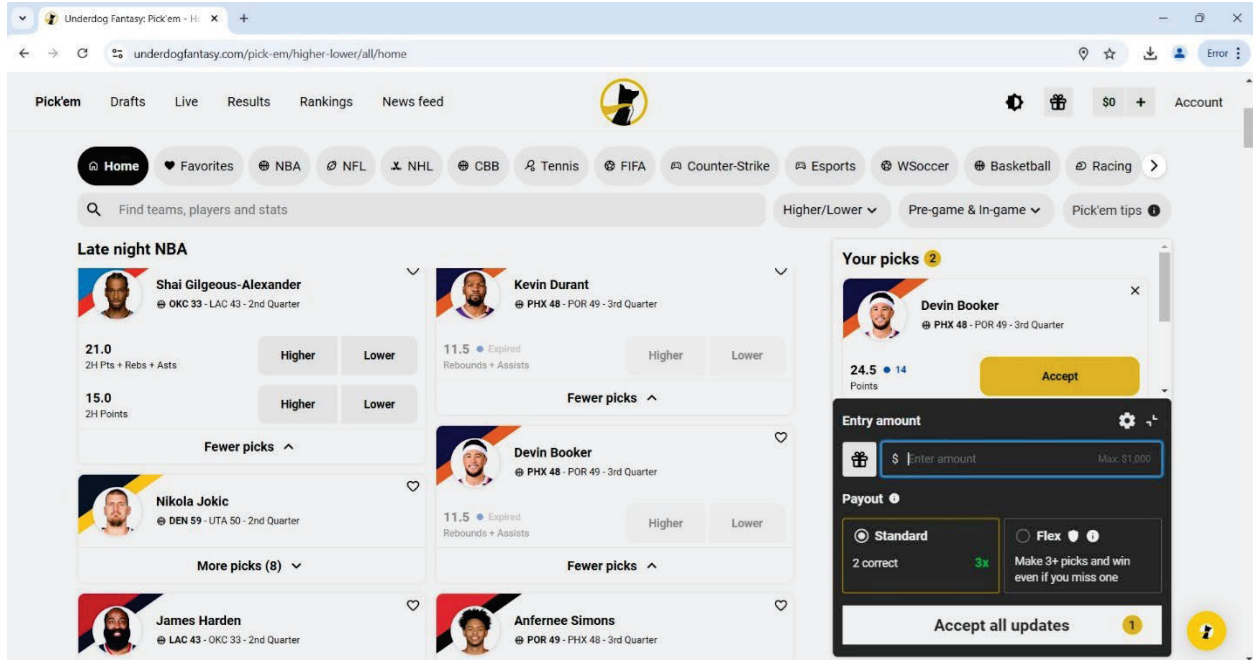
15. Within a chosen sport and/or metric, Defendant displays boxes that contain specific projections.

16. A user picks "higher" or "lower" within a given box, signaling the user's prediction that the player will either fall short of Defendant's projection or exceed it.

17. Some boxes feature "Rivals," putting two players head-to-head. A user picks which player will have a higher or lower statistic, such as points, goals, or yards. Defendant may adjust these choices so that one player must overcome a handicap to be considered the winner.

18. The screenshot below, taken from Underdog Fantasy, shows some projections

made by Defendant for professional basketball:



19. As an example, the upper-left hand box shows Shai Gilgeous-Alexander, a guard for the Oklahoma City Thunder. Defendant projected that Shai Gilgeous-Alexander would have 15.0 points in the second half of a game against the Los Angeles Clippers. An Underdog Fantasy user could pick whether Shai Gilgeous-Alexander would actually have more or less than 15.0 points in the second half of the game.

20. A user has to make picks on at least two different boxes to create an “entry.” An entry can include players and projections from different teams, games, or even sports.

21. A user must choose whether his entry will be “Standard” or “Flex.” With a Standard entry, the user only wins if all his picks in the entry are correct. If a user makes three or more picks, he can choose for them to be a Flex entry. With a Flex entry, the user can make one incorrect pick and still win. If a user wants to Flex six, seven, or eight picks, it must be a “Double Flex” entry, which allows the user to make two incorrect picks and still win. Winning with a Standard entry is more difficult but has a higher payout.

22. A user decides how much money to stake on an entry. Defendant calls this an “entry fee” or “entry amount.” The entry fee is taken out of the funds the user deposited with Defendant. Underdog Fantasy has a minimum entry fee of \$1. The website shows the potential payout for whatever entry fee the user chooses.

23. Once a user has made his picks, chosen between a Standard entry and a Flex entry, and selected an entry fee, the user submits his entry. At that point, the user has committed to his picks, and his money is at risk.

24. If a user wins with his entry, Defendant credits his account with money. The potential payout for a winning entry is more than the user’s entry fee.

25. Defendant states on its website, “\$1 BILLION+ WON ON UNDERDOG,” and “WIN UP TO 325x YOUR MONEY.” Underdog Fantasy, <https://underdogfantasy.com> (last visited Dec. 10, 2024).

26. A user can withdraw his winnings to a bank account or PayPal account. A user must withdraw a minimum of \$10 at a time, except that if he has less than \$10 available, he can withdraw the entire balance.

27. A user’s winnings at Underdog Fantasy are subject to federal income taxation. Defendant issues a Form 1099-MISC to any user who accumulates \$600 or more in net winnings during a calendar year. Defendant also submits a copy of the user’s Form 1099-MISC to the Internal Revenue Service.

28. In the Pick ’Em games offered in Georgia, a user only interacts with Defendant. A user in Georgia does not participate in a group or league, nor does he compete against other users.

29. In certain other states, Defendant offers a different type of game called

“Champions.” A Champions game is a peer-to-peer contest where users compete against each other to split a guaranteed prize pool. Defendant does not offer Champions games in Georgia.

30. Upon information and belief, Defendant uses IP addresses and software to detect where a user is accessing the website from and, based on the user’s location, offers either Pick ’Em games or Champions games.

31. Several states have told Defendant to stop offering Pick ’Em games (the same games offered in Georgia) because they are illegal gambling.

32. For example, on or about July 5, 2023, the Wyoming Gaming Commission sent a letter to Defendant stating that its business “is considered sports betting and not in compliance with Wyoming’s statutes governing fantasy sports contests.” The letter told Defendant to cease all noncompliant business in Wyoming until Defendant obtained an online sports wagering operator license or until it complied with the fantasy sports contest requirements.

33. On or about September 19, 2023, the Florida Gaming Control Commission sent a letter to Defendant stating:

The Florida Gaming Control Commission has received information that your company may be offering or accepting illegal bets or wagers from Florida residents. We have also received information that your company may be promoting and conducting an illegal lottery. This alleged conduct is strictly prohibited in Florida and constitutes criminal activity.

....

Accordingly, as Executive Director of the Florida Gaming Control Commission, I am hereby demanding you immediately cease and desist offering or accepting bets or wagers from residents of this state on the results of any contests of skill such as sports betting, including, but not limited to, bets or wagers made in connection with fantasy sports.

34. In February 2024, the Massachusetts Attorney General sent cease and desist letters to several other entities that offered pick ’em-style games, stating that such games are sports wagering under Massachusetts law. The Massachusetts Attorney General communicated



with Defendant on this same issue. Under pressure from the Massachusetts Attorney General, Defendant voluntarily discontinued Pick 'Em and switched to Champions in Massachusetts. A spokesperson for Defendant announced, "In consultation with the Massachusetts Attorney General's office, we've moved to our peer-to-peer pick'em product in Massachusetts."

35. On or about February 15, 2024, the Administrator of the Regulatory Division of the Arkansas Department of Finance and Administration sent a letter to Defendant that stated:

[I] am hereby demanding you immediately cease and desist offering or accepting bets or wagers or other similar instruments from residents of this state. This determination is not limited to your offerings in the category of "player props," a component of sports betting, but includes and is not limited to, bets or wagers or other similar instruments offered in connection with fantasy sports.

36. On or about May 21, 2024, Defendant entered into a Consent Agreement with the Director of the Gambling Control Unit within the Maine Department of Public Safety and the State of Maine Office of the Attorney General. In Maine, as in Georgia, Defendant offered Pick 'Em games, in which users predicted how individual athletes would perform in events. The Consent Agreement noted that these were "single-patron contests" and that users did not compete against each other. Although Defendant had a license to operate fantasy sports contests, the Director of the Gambling Control Unit found that Defendant's Pick 'Em games violated Maine law. Defendant ceased offering Pick 'Em games in Maine and agreed to pay a fine of \$101,881.

37. Upon information and belief, thousands of people in Georgia have lost money to Defendant on Underdog Fantasy Pick 'Em games in the past four years.

38. For example, Jamal Rashad of Augusta, Georgia, spent \$15 on a four-pick Standard entry at Underdog Fantasy. He picked Anthony Davis, a basketball player on the Los Angeles Lakers, to have higher than 29.0 points in a March 7, 2023, game against the Memphis

Grizzlies. He picked Kyrie Irving, a basketball player on the Dallas Mavericks, to have higher than 26.0 points in a March 7, 2023, game against the Utah Jazz. He picked Stephen Curry, a basketball player on the Golden State Warriors, to have lower than 5.5 rebounds in a March 7, 2023, game against the Oklahoma City Thunder. Finally, he picked Mikal Bridges, a basketball player on the Brooklyn Nets, to have higher than 24.5 points in a March 7, 2023, game against the Houston Rockets. Since this was a Standard entry, every pick had to be correct for Jamal Rashad to win.

39. Jamal Rashad lost on this entry because Stephen Curry had six rebounds in his game. Therefore, Jamal Rashad lost \$15 to Defendant on March 7, 2023.

40. Upon information and belief, Jamal Rashad has not brought an action to recover this loss from Defendant.

#### **COUNT I: RECOVERY OF GAMBLING LOSSES**

41. Plaintiff incorporates the foregoing allegations as if fully set forth herein.

42. Georgia law provides:

Money paid or property delivered upon a gambling consideration may be recovered from the winner by the loser by institution of an action for the same within six months after the loss and, after the expiration of that time, by institution of an action by any person, at any time within four years, for the joint use of himself and the educational fund of the county.

O.C.G.A. § 13-8-3(b).

43. In Georgia, a person commits the criminal offense of gambling when he “[m]akes a bet upon the partial or final result of any game or contest or upon the performance of any participant in such game or contest.” O.C.G.A. § 16-12-21(a)(1).

44. For purposes of the criminal offense of gambling, a “bet” means “an agreement that, dependent upon chance even though accompanied by some skill, one stands to win or lose something of value.” O.C.G.A. § 16-12-20(1).

45. Underdog Fantasy users in Georgia have paid money to Defendant to gamble on the performance of athletes and other contest participants.

46. In doing so, Underdog Fantasy users in Georgia have gambled directly with Defendant, as opposed to other users.

47. Defendant misleadingly describes the money gambled by users as an “entry fee” or “entry amount.” In reality, users in Georgia risk their money on the performance of athletes and other contest participants for the chance to win a prize.

48. Defendant awards money to Underdog Fantasy users in Georgia as a prize for winning entries. The potential prize includes the sum of money gambled by a user plus an additional sum.

49. The outcome of such bets depends on chance.

50. Underdog Fantasy users in Georgia have lost, and Defendant has won, money gambled on the performance of athletes and other contest participants.

51. Defendant’s Pick ’Em games are illegal gambling under the Georgia Code and Georgia common law.

52. Pursuant to O.C.G.A. § 13-8-3(b), Plaintiff seeks to recover all money and property lost by Georgia Underdog Fantasy users who have not filed their own actions under the statute, excluding any judge(s) presiding over this action and the immediate family members of such judge(s).

### **PRAYER FOR RELIEF**

**WHEREFORE**, Plaintiff prays for the following relief:

1. That service of process be had upon Defendant and that Defendant be required to appear and answer this complaint within the time prescribed by law;

2. A declaration that Defendant's conduct alleged herein is illegal gambling;
3. An order enjoining Defendant's wrongful conduct;
4. Recovery of gambling losses pursuant to O.C.G.A. § 13-8-3(b);
5. Pre-judgment and post-judgment interest, as provided by law;
6. An award of reasonable attorney's fees, litigation expenses, and court costs; and
7. All other relief, legal or equitable, that may be just and proper.

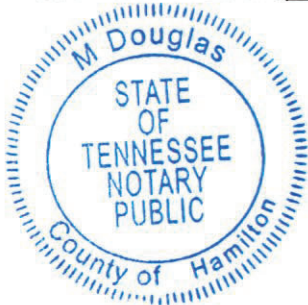
